<u>KANYA MAHA VIDYALAYA , JALANDHAR (AUTONOMOUS)</u> INSTRUCTIONS FOR THE CANDIDATES (THE INSTRUCTIONS MUST BE READ VERY CAREFULLY BEFORE FILLING THE RE-EVALUATION FORM) A candidate who wishes to seek re-evaluation of her answer-book/s may apply for re-evaluation to the Controller of Examinations, Kanya Maha Vidyalaya, Jalandhar - 144004 on prescribed application form accompanied with fee of Rs.1000/- (for undergraduate & postgraduate classes ) per answer- book alongwith Rs.200/-as Form Fee and the internet copy of detailed marks card. The application form must be submitted in the college office with in stipulated period.

The re-evaluation form neatly filled in by the candidate herself along with requisite fee and the documents mentioned above must reach the college office under a registered cover / By hand within 21 days from the date of declaration of the result of the particular examination ( for this purpose the date printed on the result Gazette Notification shall be taken as the date of declaration). No grace days will be allowed after stipulated period fixed by the college authorities.

(ii) A candidate may be allowed to withdraw her application for re-evaluation within 10 days of the submission of her reevaluation form.

No refund of fee shall be admissible after the deposit of the fee for re-evaluation.

Late procurement of form shall not be entertained as a plea for its late submission in any case.

A candidate will not be entitled to apply for re-evaluation after the expiry of the normal dates mentioned above if her result has been delayed on account of her own fault.

Only one application form should be used for one or more courses / papers.

All entries in the application for re-evaluation should be complete and correct in all respects. The office will not be responsible for the delay/rejection of the case, if the form is not complete in all respects or not be accompanied by full fee and/or detailed marks card /certificate. No change in the entries once made by candidate shall be allowed after the receipt of the form by the office.

Ignorance of the titles of course or option shall not be accepted as a plea for wrong entry in the application form.

Fee should only be deposited in cash at the college counter with the cashier on working days. NOTE:- a) Payment by cheque is not acceptable.

b) The College Cash Receipt, in original, must be attached with the application form.

- Re-evaluation is permissible in the case of Supplementary and Semester Examinations conducted by this college except in the following:
  - i) Practical Examinations in different courses / papers, continuous assessment; internal assessment of project report, dissertations, thesis and viva voce.
  - ii) The courses where grading system has been introduced and the marks will not be included in the maximum marks of semester or Programme.

iii) The Examinations in which the answer-books are marked by the external and internal examiners.

- The Re-evaluation will be done under the rules framed by college from time to time and the result will be communicated to the candidates soon after it is declared. No interim communication to this effect will be entertained.
- 11. Each script will be re-evaluated as a whole by two examiners separately. Re-evaluation result will be declared as per re-evaluation policy of the college.

12. The score of re-evaluation shall supersede the original score.

- 13. The result of re-evaluation whether favourable or unfavourable, shall be binding upon the candidate who applies for re-evaluation.
- 14. If the candidate has already availed the benefit of 1% grace marks to pass any course, after re-evaluation, the priority of grace may be awarded to the course for which the candidate has applied for re-evaluation.

15. No further re-assessment shall be allowed after the award/s by Re-evaluation has/have been received.

- 16. A candidate will be permitted to see her answer-books for identification only, on payment of an additional fee of Rs.1000/- per answer-book during working hours on a written request within 15 days from the date of declaration of the result of re-evaluation. The facility is provided to enable a candidate to see herself that the answer book/s shown to her is her own.
- 17. If as a result of re-evaluation a candidate passes the examination, she shall be eligible to seek admission to the next higher class within 10 days after the declaration of re-evaluation result. Her attendance shall be counted from the date of admission.

Similarly, if a candidate becomes eligible for the Supplementary Examination, she may be permitted to appear in the usual Supplementary Examination. Such a candidate may seek provisional admission to the next higher class within 10 days after the declaration of re-evaluation result only if she is eligible for the same as per examination policy of the college and her attendance shall be counted from the date of admission.
